We have offices in 106 countries worldwide assisting more than 25 000 Christian schools that includes 5, 5 million students globally.

ACSI Southern Africa is a regional office that supports and partners with independent Christian Schools in Southern Africa. We currently service schools in South Africa, Eswatini (Swaziland) and Zimbabwe.

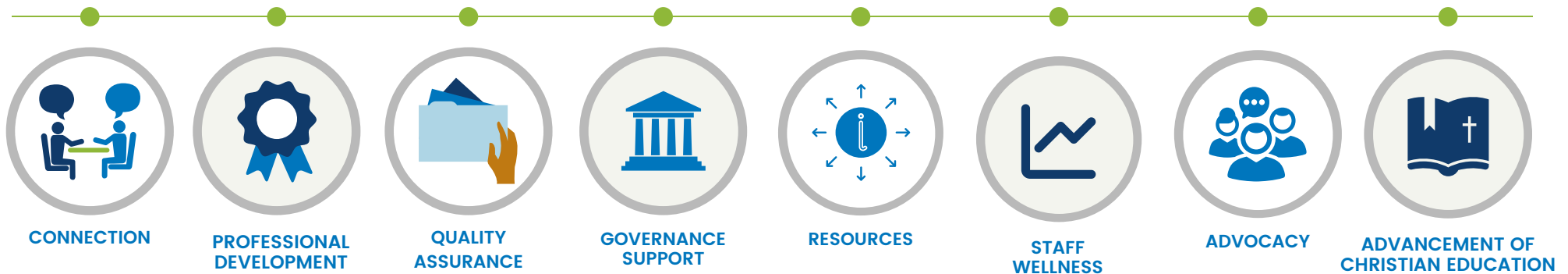


ACSI OUR SERVICES

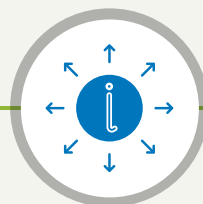

PUBLIC ENGAGEMENT

We are committed to influence public policy and public perception that have an impact on Christian schools and the rights of Christian educators everywhere. We seek appropriate representation to protect the rights of parents to be free to choose the educational programme that in their view best meets the educational and spiritual needs of their children. We are committed to working in collaboration with families, churches, governments and other leaders and organisations to promote school compliance with all applicable laws whilst defending the right of private individuals or groups to establish and support Christian schools without restriction or reservation.

STAFF AND THEIR GROWTH

We establish personnel resources and organisational policies and practices that encourage equitable and competitive wages. ACSI will support continuing professional growth and a commitment to collaborative goal setting, accountability, and consistent implementation of evaluation systems.

- His vicarious and anointing death (1 Corinthians 15:3; Ephesians 1:7; Hebrews 2:9)
- His resurrection (John 11:25; 1 Corinthians 15:4)
- His ascension to the right hand of the Father (Mark 16:19)
- His personal return in power and glory (Acts 1:11; Revelation 19:11)

In the absolute necessity of regeneration by the Holy Spirit for salvation because of the exceeding sinfulness of human nature; and that men are justified on the single ground of faith in the shed blood of Christ and that only by God's grace and through faith alone are we saved (John 3:16-19; John 5:24; Romans 3:23; Romans 5:8-9; Ephesians 2:8-10; Titus 3:5)

In the resurrection of both the saved and the lost; they that are saved unto the resurrection of life, and they that are lost unto the resurrection of damnation (John 5: 28-29)

In the spiritual unity of believers in our Lord Jesus Christ (Romans 5: 8-9; 1 Corinthians 12:12-13; Galatians 3:26-28)

In the present ministry of the Holy Spirit, by whose indwelling in the Christian, we are enabled to live godly lives (Romans 8:13-14; Corinthians 3:16; 1 Corinthians 6:9-16; Ephesians 4:30; Ephesians 5:18)

ACSI CODE OF ETHICS

SPIRITUALLY

- Live according to the Word of God.
- The Statement of Faith of ACSI.
- The Vision and Mission Statement of ACSI.
- The Core Beliefs of ACSI.
- Acknowledge the noble calling of our profession to educate and train the learners in our schools in Spirit and in Truth, according to God's Word.

ADMINISTRATIVELY

- Adhere to relevant legislation for existing as an independent school
 - Observe good practice.
 - Meet local health, safety and sanitation standards
 - Operate within the parameters of the constitution of our country
1. Do not discriminate on any basis
 2. Are registered with the State / Provincial Education Department
 3. Maintain standards that are not inferior to standards at comparable public educational institutions;

PRINCIPALS AND BOARDS

- Engage in ongoing school improvement and in the core components (as outlined in ACSI's Essential Elements of an Effective Christian School):
 1. Truth
 2. Intellectual Development
 3. Christian Educators
 4. Potential in Christ
 5. Operational Integrity
- Sound and effective management and control
- Offer adequate programmes to meet the needs of all admitted students
- Hire educators who are qualified
- Maintain the freedom to provide an educational programme which satisfies academic standards
- Provide facilities that are appropriate for the educational programmes that ACSI may offer.



AS EDUCATORS

- Act in a proper and becoming way such that their behaviour does not bring Christ or the teaching profession into disrepute.
- Acknowledge the uniqueness, individuality, and specific needs of each learner, guiding and encouraging each to realise his or her potential as stated in Psalm 139:14: “You are fearfully and wonderfully made.”
- Endeavour to enable learners to develop a set of values consistent with the Word of God.
- Pursue excellence in every area of education.
- Provide for the Spiritual, Intellectual, Emotional and Physical needs of the learners.

- Teach from a Biblical Worldview perspective, focusing on Spiritual Formation.
- Educate towards reaching the expected student outcomes as set by ACSI.
- Offer adequate programmes to meet the needs of all admitted students.
- Teach, learn and assess knowledge, skills, values and attitudes.
- Acknowledge that the attitude, dedication, self-discipline, ideals, training and conduct of the teaching profession determine the quality of education in our schools.
- Exercise authority with compassion.
- Avoid any form of humiliation, and refrain from any form of abuse, physical or psychological.

- Use appropriate language and behaviour in any interaction with learners, and act in such a way as to elicit respect from the learners.
- Take reasonable steps to ensure the safety of the learners.
- Not show negligence or indolence in the performance of their professional duties.
- Recognise the parents as partners in education, and promote a harmonious relationship with them.
- Do what is practically possible to keep parents adequately and timeously informed about the well-being and progress of the learner.
